

# **Checklist, Important General Information and Fees for Spring 2011 Boys Park City High School Lacrosse**

***All*** of the following registration processes and payments (all items 1-7 on this list) are **required of all players in order** to participate on the PCHS Varsity and JV Teams. You will not be able to attend practices nor play in any games unless **all** conditions are met. **No exceptions.**

## **1) Register with US Lacrosse**

High School Player Membership Fee - **\$35.00**

Sign up or renew your membership at [www.uslacrosse.org](http://www.uslacrosse.org)

Membership is valid for one year. Must be valid thru **May 31, 2011**

When becoming a new member or renewing your membership, you will be asked during the registration process what group(s) you would like to be associated with. You may choose 2414576, Utah Lacrosse Association, as well as any other groups that your son is associated with.

## **2) Register with the Utah Lacrosse Association (ULA)**

High School Player Fee - **\$112.00** (Fee increases after February 15, 2011)

**Registration Opens December 15, 2010 – Early Registration Closes February 15, 2011**

To complete registration online, you will need the following:

- VISA or MasterCard
- Current US Lacrosse Membership
- Primary Insurance and Policy Number

## **3) Register with Park City Lacrosse Organization (PCLO)**

Total Team Fee - **\$430.00**

Register/Pay Online [www.parkcitylax.org](http://www.parkcitylax.org) with VISA or MasterCard only.

**Registration Opens November 15, 2010 – Registration Closes February 15, 2011**

*Your team fee, together with proceeds derived from PCLO fundraising activities, pay for our Varsity and JV programs, which includes stipends for coaches, team gear (including pinnie and shooting shirts), use of game jerseys, field equipment, indoor practice space, game and practice fields during the season. In addition this year we intend to have a certified EMT and ambulance at all of our home games. The fee includes the cost of this new program.*

## **4) Register for mandatory Mesquite Winter Break Training Camp**

Total Camp Cost - **\$400.00**

6) **PURCHASE Team Shorts**

**Junior Varsity and Varsity players who do not already have our official red game shorts are required** to purchase them from PCLO for **\$50.00**. Send check, *payable to PCLO*, to Linda Eisenbarth along with size of shorts.

7) **REGISTER FOR VOLUNTEER PROGRAM**

- As previously announced, the PCLO has moved to a new member volunteer program whereby all families are expected to either provide 10 volunteer hours or pay a fee in lieu of hours of \$200 fee per family. As with all the items 1-6 above, players will not be allowed to practice or play in games until the PCLO has received payments from all families (regardless of intention to provide or not provide the volunteer hours). Checks in the amount of \$200 should be made payable to PCLO and given to Linda Eisenbarth at the November 30 Parent/Player/Coach meeting at PCHS. The checks will be held by PCLO Treasurer Lisa O'Brien and will be voided and destroyed at the end of the season if 10 or more volunteer hours have been fulfilled. For parents volunteering fewer than 10 hours, partial refunds will be distributed at the rate of \$20/hour at the end of the season. We would ask that families that intend to pay the fee in lieu of volunteer hours please email [carl@hoburg.net](mailto:carl@hoburg.net) so he can keep track of the numbers.
- Parents will track their volunteer hours on an honor system using the volunteer form posted on our website. (Hours for pick-up days for Christmas Tree Fundraiser are limited to two hours.)
- At the end of the season, time sheets should be submitted to Carl Hoburg who will coordinate all of our volunteer activities. They will be accepted between May 1, 2011 and five business days prior to the year-end banquet; we will communicate the exact deadline when the banquet date is set.

## **Other General Information**

### **UNIFORM**

- PCLO will *loan* 2 game jerseys.
- The jerseys belong to and shall remain the property of PCLO, not to individual players.
- **Jerseys must be returned to the PCLO representative immediately after the last game of the 2010 season. Failure to return either of the jerseys will result in the player's parent being assessed a \$150 fee.**

### **EQUIPMENT**

- Player's responsibility: regulation men's stick, cleats, mouth guard (colored required), protective cup, helmet (white shell required, red visor recommended), pads and gloves (red recommended).

### **TRYOUTS**

- Team Tryouts will be held this year at the Spence Eccles Fieldhouse in Salt Lake City on the campus of the University of Utah
- **Sunday January 9th between 2:00 and 4:00pm**

*Please note since this year's tryouts will be on a Sunday, any player who cannot make the tryouts for religious reasons will need to make other arrangements and should contact Coach Levi immediately.*

### **CHRISTMAS FUNDRAISER**

- Participation is mandatory for all players (JV & V). We encourage all players to participate on both tree pick-up dates, but at a minimum they must participate in one pickup and replace the other pickup date with time doing marketing.
