- \_\_\_ **1 - US Lacrosse Membership.** Get or renew your membership at [www.uslacrosse.org](http://www.uslacrosse.org) Membership is valid for one year. Must be valid thru **May 30<sup>th</sup> 2008**.  
\* High School Player Fee = **\$35.00**.
- \_\_\_ **2 - Register with the Utah Lacrosse Organization** by going to [www.utahlax.org](http://www.utahlax.org) Registration starts **December 16, 2007**. Late fee starts February 16, 2008. **Deadline is February 26, 2008.** The cost is **\$107.00**.

- \_\_\_ **3 - PCHS Team Fee: \$295.00** payable to PCLO. Register / Pay Online at [www.parkcitylax.org](http://www.parkcitylax.org) Registration Opens **December 16, 2007 – Registration Closes February 16, 2008** Team fee, along with the PCLO fundraiser, pays for our coaches, field equipment, and indoor practice space in winter, game and practice fields during the season and some transportation.
- \_\_\_ **Uniform: Junior Varsity** will be **required** to purchase Game Shorts from PCLO for **\$30.00**. The shorts are the same from 2005 to 2008. **Varsity** will be **required** to purchase New Game Shorts for **\$25.00** and a Shooting Shirt from PCLO for **\$25.00**.
- \_\_\_ **Uniform:** PCLO will **loan** 2 game jerseys for the season. The jerseys belong to the PCLO, not to the players. **Jerseys must be returned to Steve Mersereau immediately after the last game of the season. Failure to return Jerseys Parents will be invoiced \$150.00**
